3. PROFILE OF SKILLS AND COMPETENCES

Master craftsmen/mistresses in the chimney sweep trade have the professional, methodological, social and personal skills to manage and organise a chimney sweep company. In consideration of the customer requierements you can:

- develop a range of services and offer services, in particular:
 - considering cleaning, inspection and measuring techniques, environmental and fire protection, maintenance measures, occupational legal regulations and technical standards as well as established rules of technology, various communication channels, the use of materials, machines and equipment,
 - evaluate and create plans, sketches and drawings, including the use of computer-aided systems,
 - determine data related to structural and technical installations, of firing and ventilation systems, fire and environmental protection systems as well as stationary combustion facilities in accordance with relevant public regulations.
- provide services, in particular:
 - inspect, measure, clean and sweep firing and ventilation systems as well as other facilities to maintain operational and fire safety as well as environmental and climate protection; adjust measuring, control and regulating devices, conduct fire site inspections; identify defects, malfunctions, hazards and causes of disturbances originating from firing and ventilation systems, fuel supply systems as well as workplace safety equipment, report them to the responsible authorities; carry out immediate measures to avert hazards and eliminate causes as well as derive preventive
 - inspect and assess buildings, structural and technical installations including fuel supply systems for operational and fire safety, energy efficiency as well as environmental and climate protection, develop, initiate and oversee optimisation measures and inspect fuels for compliance with immission and environmental protection requirements.
 - lead and manage a district, in particular issue administrative acts, prepare expert opinions and statements and support competent authorities; advise clients on issues related to operational and fire safety, indoor air quality, workplace health and safety, immission, environmental and climate protection and energy efficiency,
- checking, documenting, handing over and invoicing services.

In doing so, you make commercial, human resources and legally justified decisions, implement them and justify them. This includes in particular:

plan, control and monitor work and business processes in a responsible position from an entrepreneurial perspective as well as ensure quality and sustainability

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Master craftsmen/mistresses in the chimney sweep trade independently manage companies or take on management tasks in companies and business premises of the chimney sweep trade. In craft or industrial companies, they take on in addition to providing services one or more of the following activities:

- commercial and business management,
- technical management.
- organisation of vocational training and human resources development.

Regulation on the Admission and General Examination Procedure for the Master Craftsman Examination in Craft Trades and Trades Similar to Craft Trades (MPVerfVO) of 17 December 2001 (BGBI. I p. 4154), modified by article 1 of the regulation of 26 October 2011 (BGBI. I p. 2145), last modified by article 106 of the law of 29 March 2017 (BGBI. I p. 626).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

The advanced training qualification is obtained by passing an examination bevor the under 5 named body. Admission to the examination is granted to those who provides

- 1. a successfully passed journeyman's examination or
- 2. a final examination in a recognised vocational training occupation or
- 3. a determination of equivalence in accordance with § 40a of the HwO.

In addition, further routes to examination admission are regulated in §49 HwO.

Additional information

All data refer to the status 01.2023.

The acquisition of the professional competence to be demonstrated in the further training examination usually takes place within the framework of vocational training measures. Graduates regularly have several years of professional experience.
